2011 Tax Filing Deadline at the End of April!

The deadline for most personal returns is now 29 days away. Waiting until the last minute to get your taxes done is never a good idea, especially if you need them assessed soon. Once you're ready to file your 2011 return, make arrangements TODAY rather than on April 29. I am jammed to the rafters with appointments, and you may have to wait weeks before getting in. Take advantage of our email, fax, phone or mail service. The days of office locations and 9–5 hours are becoming a thing of the past, and regrettably businesses stuck in yesterday's ways will get left there. E-File Versus Regular Paper File?

Real People with Real Questions About Real Situations

Dear Neel,

My accountant has E-filed my return for years, but recently I learned from a CRA insider that paper-filed returns have a lower chance of being audited. Can you verify this? I contacted CRA and they wouldn't say either way?

Dear Ryan,

I am not an authority on this matter, but having offered the E-file option since 2000, I have found it to be a very efficient and environmentally friendly service. Because it's paperless, it makes sense that CRA would request verification of certain claims. Moving expenses, for example, are frequently audited, because the amount is usually several thousand dollars. The same goes for high medical expenses. While CRA can't force you to E-file, a

person who paper-files a return like that, with all the receipts, is in fact not likely to be audited.

However, the time to process these returns can be longer, and an audit on other items down the road is still possible. I encourage you to continue using the E-file services in all appropriate situations. Also, take advantage of the various E-services CRA has offered for several years now. You should register for your personal login name so you can access your account or work with your accountant online to resolve a variety of issues. If you need assistance getting this set up, contact the help desk at 1-800-714-7257. Hope this helps!

The World's Largest Easter Bunny Cake!

Four confectioners from Chomutovin in the Czech Republic claim they've created the world's largest Easter Bunny Cake and hope to get a place in the *Guinness World Records*. It's not the cutest bunny but probably one of the most delicious. Creators at a cake shop spent 48 hours preparing the sweet treat in time for Easter. They used 770 eggs, 160 pounds of sponge cake, 120 pounds of cream, 44 pounds of jam, and 40 pounds of marzipan to make the themed cake, and then covered it all with a layer of chocolate. When it was finished, the big-eyed edible bunny weighed over 370 pounds and measured over 6 feet in length.

On Easter Day the chocolate bunny cake was sliced into pieces and handed to people in the Czech town of UherskéHradiště. Everybody loves cake, but some people were a little freaked out by the bunny's appearance. "It might taste sweet, but you wouldn't want to run into it in a dark alley," a customer of the cake shop said. Freaky or not, this one-of-a-kind Easter cake is awaiting confirmation from the *Guinness World Records* for the world's largest Easter Bunny Cake. When I first saw it, I thought it was a modern-day Egyptian Sphinx!
