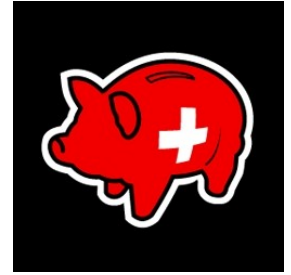
### New Login Required to Access Your Tax Information

If you already have an Epass, now you will need to register to CRA's unique Login user name and password as of last fall. This not only applies to professionals like me but those who are both personal and business users. ### Beware Unreported Swiss Bank Account Holders

The days of finding secrecy in Swiss bank accounts without paying taxes is fast coming to a close as CRA now has the names and account details of those who have been eluding the taxman for years. The House of Commons finance committee launched a formal investigation 2 months ago into allegations hundreds of Canadians have stashed millions in offshore banks to hide their wealth from Canada's taxman. "Honest hard working Canadians are worried the rich are manipulating the system", said Liberal finance critic Scott Brison. Those who find themselves in this situation should ask us about a "Tax Amnesty" to avoid persecution and more!



### Last call for a 100% Computer Claim for Businesses

As the current Economic Action Plan expires, small businesses who purchase a computer can claim a 100% capital cost allowance for all computing equipment purchased up to January 31st, 2011. This is almost double from the current 55% and pretty well covers any type of computing equipment including smart phones. ### Tax Ombudsman Slam CRA for Rejecting Appeals

Last month, Canada's first Tax Ombudsman Paul Dube criticized the CRA for unreasonably rejecting tax appeals for no good reason. In his November report, The Right to Know, Mr. Dube, a former criminal defense lawyer cited a "definite pattern" of appeals officials refusing to allow taxpayers to have their objections heard. "Reasons are part of democracy," Dube said Wednesday during an interview in his office. "You have the right to know why a decision was being made. You need the reasons from that decision to be able to launch an effective appeal." According to the Taxpayer's Bills of Rights legislated in 2007, a taxpayer now has documented appeal rights that the CRA "**MUST**" permit regardless of the application officer's opinion. If you feel you have been denied this basic fairness, contact the Tax Ombudsman at 1-866-586-3839.



### Are you "Tax Preparation Volunteer" Material?

Have you ever considered a profession preparing taxes but lack experience? The "Tax Volunteer Program" is an excellent program to get started in as there are minimal qualifications. This experience can be very helpful if you want to pursue a career in the tax industry. Many professionals actually started here before going into practise full time. I even heard a rumour they have a free meal at the end of the season but you have to bring your own ketchup, so don't let that discourage you. ### New Global Accounting Standard coming to The Canadian Tax System!

Beginning in 2011 there will be a new set of accounting principles known as "International Financial Reporting Standards (IFRS)" which affect the way CRA requires individuals and corporations to report income. As news gets released, I will keep you updated or you can follow various websites through RSS feeds, but expect the bulk of the new practises to be announced in mid-2011 for the 2012 tax season.



## “Missing in Action and Need to get Back in the Tax Loop”

Real People with Real Questions About Real Situations

Dear Neel,

I have moved so many times in the last ten years and forgot to file at the same time that CRA thinks I'm cheating them. To make a long story short I had a lot of personal difficulties including illness, death in the family and financial problems. I was self-employed and employed at various places but I don't think I owe them and probably entitled to GST/Child Tax benefits. I really liked your website and hope you can help because I feel totally alone!

Dear Curtis,

I can assure you you're not the first person I have met in this situation and doubt it'll be the last however this does not mean you should take your circumstances lightly. Understand that CRA can only react to the information they have at hand and if you have the impression they are harassing you, I suggest you write them a detailed letter explaining your situation. Not only does it look like you can qualify for fairness under the Taxpayer's Bill of Rights, but CRA "MUST" by law conduct themselves in a

courteous and ethical manner. If you feel this has not been the case, I suggest you start by filing a Service Complaint and even contacting the CRA Ombudsman at 1-866-586-3839.

Addressing your late taxes, you need to gather your information for each year and you should start by calling the general enquires # at 1-800-959-8281. Have them mail all slips they have on the database for unfiled years and fill out the Moving Expense Form T1M for each qualifying move. If you are using a tax professional, they can guide you with the self-employed years and our personal tax checklist with Small Business Tax Booklet & Excel business spreadsheet will help you compile the rest. Lastly, see if you qualify for the Disability Tax Credit as not only can you go back 10 years but you can use it for future returns. Merry Christmas and the very best for the New Year!
