If you need several years filed, or your situation is complicated, use our [Get Started Now](#) form. Both are interactive, so you don't have to print anything and can email the forms directly to me. Most people who switch over to this method don't want to switch back. Not only do they save time but the service is more efficient.

2009 was without a doubt a challenging year for many. With the downturn in the global economy, it was hard to escape the rash of cutbacks that resulted in less work. # What's Happening

## 2010 Federal Budget

At the beginning of March, Minister of Finance Jim Flaherty tabled the latest Federal Budget. While cuts in the civil service were the main rollback, the stimulus continues to aid the recovering economy, and no new tax levies were introduced. ## More Breaks for the Disabled

CRA announced at the beginning of the year tax incentives for those who are legally disabled. Compared to a few years ago, there are many more breaks today, and they are all listed on CRA's [Persons with disabilities website](#). ## Remember Those Home Renovation Receipts

Many of the returns I have processed so far have been taking advantage of this one-time tax break. Simply put, save all your receipts from January 27, 2009, to February 1, 2010, up to \$10,000 (minimum \$1,000) for renovating the home you own. Most expenses incurred to improve your personal residence, such as rebuilding a kitchen, are allowable, but not items for regular maintenance, such as snow clearing or lawn cutting. ## Compliance—Be Prepared If CRA Asks

I read a lot of bulletins and articles on trends in the tax and accounting industry. One of the items that comes up often is how CRA is addressing taxpayer compliance. In other words, is the tax return reporting the correct amount, and does the taxpayer have the documentation to support it? The law has always stated that what's reported on the return must be not only accurate but also substantiated with appropriate receipts, etc. If their revenues are healthy, CRA may not audit as many returns. But, since the downturn in late 2008, the massive deficits the Canadian government has racked up may trigger the auditors to go looking for cash, and they can go back as far as six years. I have not noticed a jump in audits from my clients, but I am cautioning everybody to be prepared to get a letter from CRA requesting proof of your transactions. ## CRA Announces Tax Relief for Canadians Affected by Natural Disasters

CRA announced earlier this month that Canadians participating in relief efforts or affected by natural disasters who are unable to meet their tax obligations will be able to readily access tax relief measures. "In cases such as the recent earthquakes in Haiti and Chile, as well as in any other potential natural disasters, our Government is sensitive to the difficulties that individuals and businesses may encounter as a result of unpredictable natural disasters," said Minister of National Revenue Keith Ashfield. "As has been done in the past, the Canada Revenue Agency will continue to provide relief to taxpayers by giving special consideration when they are unable to meet their tax obligations due to natural disasters." Taxpayers should submit their request in writing using form RC4288, [Request for Taxpayer Relief](#). The CRA will consider these requests on a case-by-case basis. ## CRA Offers Free Tax Seminars

CRA is offering the general public tax seminars on a variety of subjects. Seminars for individuals include such topics as: seniors and income tax, the Child Disability Benefit, and newcomers to Canada. Seminars for businesses include such topics as: registering for a GST/HST account, payroll requirements, T4 slip preparation, and more. Unfortunately, there are unscrupulous people who will exploit a catastrophe like this, not only using your hard-earned money for their own benefit but also jilting you out of a legitimate tax deduction.



## Paying Taxes at the Bank? Make Sure You Use the Original Form and Not a Photocopy!

Are you paying your personal, corporate or GST taxes at the bank? CRA is now emphasizing that you use the original remittance forms instead of copies. These specially made papers contain magnetic ink and are encrypted to direct your payment to the correct department. ## Help CRA Snuff Out the Tax Phonies

March was fraud prevention month, and CRA is reminding Canadians that the minority of tax preparers and promoters who try to make money at the expense of Canadian taxpayers are not getting away with it. "Canadians should know that honest tax preparers and promoters are an important part of the tax system, and that the vast majority are professionals who fully respect tax laws. But there are some who engage in fraudulent activity," said Minister of National Revenue Keith Ashfield. "Our government is committed to protecting taxpayers; we want Canadians to be educated about different types of fraudulent activity and know that unscrupulous third parties who victimize law-abiding citizens can be severely penalized under the law." ## Ontario and British Columbia: Transition to the HST—Direct Sellers and Independent Sales Contractors

The governments of Ontario and British Columbia have each proposed a harmonized sales tax (HST) that will come into effect on July 1, 2010. The HST rate in Ontario will be 13%, of which 5% will represent the federal part and 8% the provincial part. British Columbia has proposed a 12% HST (5% federal and 7% provincial). Expect several more updates before the July 1 switchover, but for now check out the [news bulletin](#) regarding direct sellers and independent sales contractors.

The deadline for most personal returns is now 32 days away. Waiting until the last minute to get your taxes done is never a good idea, especially if you need them assessed soon. Once you're ready to file your 2009 return, make arrangements TODAY rather than on April 29. I am jammed to the rafters with appointments, and you may have to wait weeks before getting in. I have lived in my father's house for years (he lives in a nursing home). My family just pays the expenses, like taxes, hydro, etc., so we are not

renters. We will eventually inherit the house and take on all the responsibilities of being an owner. We have Power of Attorney over the property, so my father is not involved anymore. We recently did renovations to start a small business and are wondering if we qualify for the Home Renovation Tax Credit.

Dear Ralph,  
While you and your family act like owners and have taken on all the responsibilities of the property, the problem that may prevent you from claiming the Home Renovation Tax

Credit (HRTC) is that your dad, rather than you and your spouse, is still on title. One of the conditions for claiming the credit is that you owned the property, so CRA will treat you like renters even though no money has changed hands between you and your dad. You can call the hotline at 1-877-959-1272 for more information. You mentioned that these renovations were made to start a small business. It is not a total loss because you can, in fact, claim a portion of them under business expenses. Check out our Small Business Tax Booklet and the CRA Business Income guide for details. ## Did You Know?



Easter is an interesting holiday for astronomical reasons. The Christian Church didn't pick the date out of thin air. It is based on an ancient lunar calendar using the Jewish calculation for Passover, the 14th day of Nisan, or the month spring begins. Jewish months begin with a new moon. Fourteen days later is the full moon. This full moon is called the "Pascal Full Moon" and begins the Passover celebration. For Christians, Passover and Easter are associated with Jesus's ill-fated visit to Jerusalem. Hence the Easter rule became simply, "The first Sunday after Passover." Technically more correct, using the astronomical definition of spring, this became "The first Sunday after the first full moon after the vernal equinox."
